Strategy

Xtrackers Japan JPX-Nikkei 400 Equity ETF (JPN) seeks to track the JPXNikkei 400 Total Return Index, a benchmark consisting of 400 Japanese securities that pass a rigorous screening process. The index uses indicators such as return on equity (ROE, the amount of net income returned as a percentage of shareholders' equity), cumulative operating profit and market capitalization to select high-quality, capially-efficient Japanese companies.


