Strategy

Xtrackers MSCI South Korea Hedged Equity ETF (the "ETF") seeks investment results that correspond generally to the performance, before fees and expenses, of the MSCI Korea 25/50 U.S. Dollar Hedged Index (the "Index"). The Index is designed to provide exposure to South Korean equity markets, while at the same time mitigating exposure to fluctuations between the value of the U.S. dollar and the South Korean won.



⁴ Price-to-earnings ratio (P/E) is a stock's current price divided by the company's trailing 12-month earnings per share from continuous operations.

⁵ Dividend yield is a weighted-sum of the annualized dividends of the index components divided by the most recent index value. Annualized dividends are determined using a sum of all dividend announcements during the previous 12 months. Dividend yield is that of the MSCI Korea 25/50 Index and is the rate of income generated by a stock in the form of dividends. The dividend yield of the index should not be considered the dividend yield of the fund.
